READ ENTIRE DOCUMENT BEFORE SIGNING!

*There is a participation fee of \$650 per team.

*If a team forfeits for any reason, they may be subject to the \$100 forfeit fine payable to the **lffo**.

*Players realize that if their absence contributes to a forfeit by the team they're signed with, they may receive a lifetime suspension from the **lffo**.

*No player may begin play until he has COMPLETELY filled out and signed this waiver and submitted it to the **lffo**.

PLAYER CARD INFORMATION:

All players are required to purchase a player card for \$20. This player card indicates that they are an active 'player in good standing' and are able to participate in activities as conducted by the Lakeshore Flag Football Organization. Players realize that if their conduct warrants suspension, they may lose their status as a 'player in good standing' and may have to purchase a card again for \$20. In certain circumstances, a player may be suspended permanently and no longer will be able to purchase a player card and participate in LFFO activities.

WAIVER AND RELEASE OF LIABILITY

I acknowledge that I have voluntarily applied to participate in flag football as offered by the Lakeshore Flag Football Organization. I understand that flag football does involve risk of personal injury and I am aware of the dangers with participating in flag football, including but not limited to any injuries resulting from collisions with other participants or falling to the ground, contact with field markers or scoreboards, muscle pulls and strains and/or contact with observers. **I hereby assume ALL RESPONSIBILITY and risk for injuries occurring as a result of my participation in the Lakeshore Flag Football Organization.**

I understand that the activities of Lakeshore Flag Football Organization will take place in various venues, including public parks and lands. I acknowledge that such venues have NOT been maintained by the Lakeshore Flag Football Organization. I also acknowledge that these venues are NOT guaranteed by the Lakeshore Flag Football Organization, and that I may be injured as result of the condition of such venues, e.g. depressions, debris, etc. I acknowledge the risks associated with the venues in which activities of the Lakeshore Flag Football Organization may occur, I further assume ALL RESPONSIBILITIES for injuries occurring from these venues and their maintenance and through my participation in any activities offered by the Lakeshore Flag Football Organization.

I release and discharge the Lakeshore Flag Football Organization and any of its officers, directors, agents and assigns from all claim, demands, rights or causes of action, present or future, resulting from or rising out of, or incident to, my participation in flag football activities offered through the Lakeshore Flag Football Organization.
